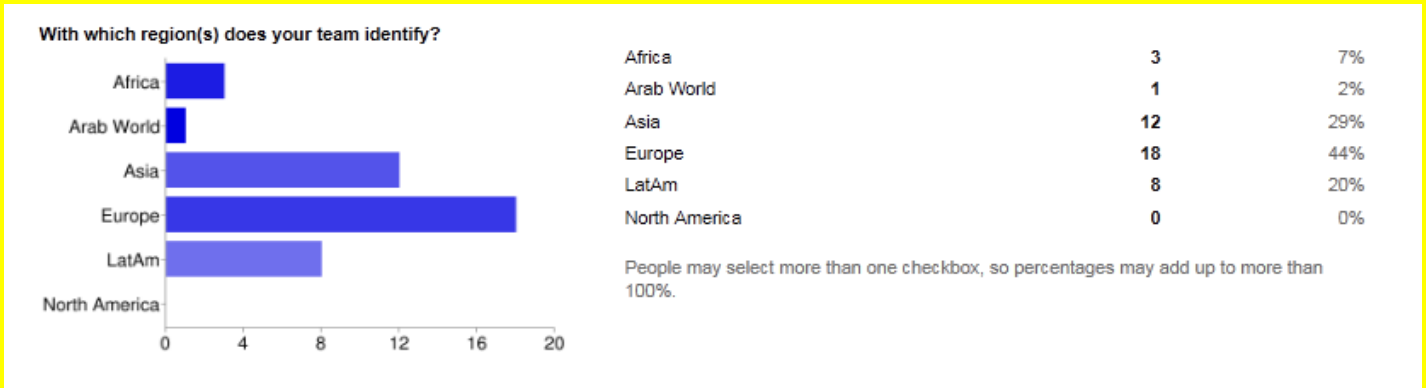


Survey and Respondents Overview

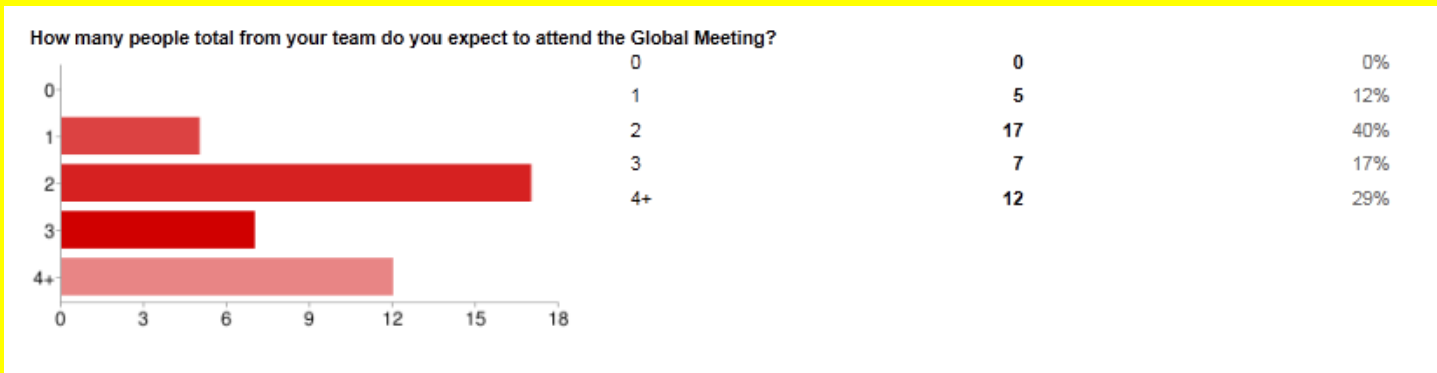
The Global Summit Survey was open for responses from [date] to 17 June 2011. 41 people from 26 teams contributed their input. Of those 41, only 1 person said he did not expect to attend the Global Summit. Most of the survey respondents were from Asia and Europe. Throughout the Summit report, all references to attendees or potential attendees refers only to those 41 who responded to the survey.

59 – 61+ Attendees expected from the 26 teams that responded to the survey;

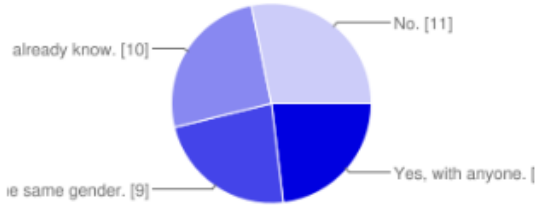

Are you willing to share a hotel room?



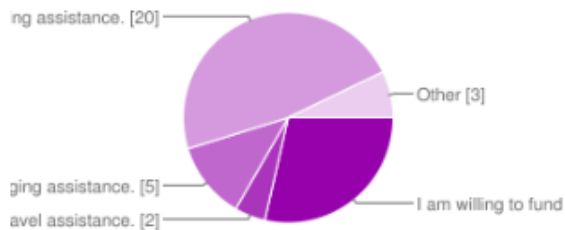
Yes, with anyone.	9	22%

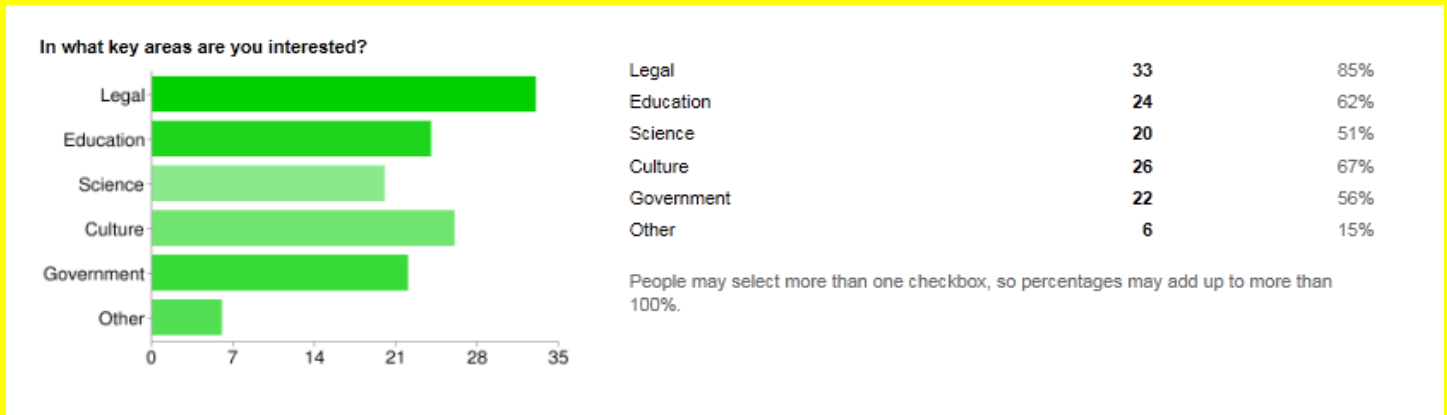

Session logistic suggestion to note:

“On the methodology of the sessions, I would like to see as few conference—type sessions as possible, and also as few parallel sessions as possible, in order to avoid dilemmas, and enable discover new topics (or work with colleagues outside the sessions). Also, I hope keynote-type presentations will be avoided, and that presentations will be kept to 10 min and aim at facilitating exchange and real working sessions. For instance on psi: cc-it, au, nl and okf (for instance) would present local experiences for 10 min each and 30 to 60 min would be dedicated to a real exchange, transfer of competences and adaptation of strategies to local environments.”

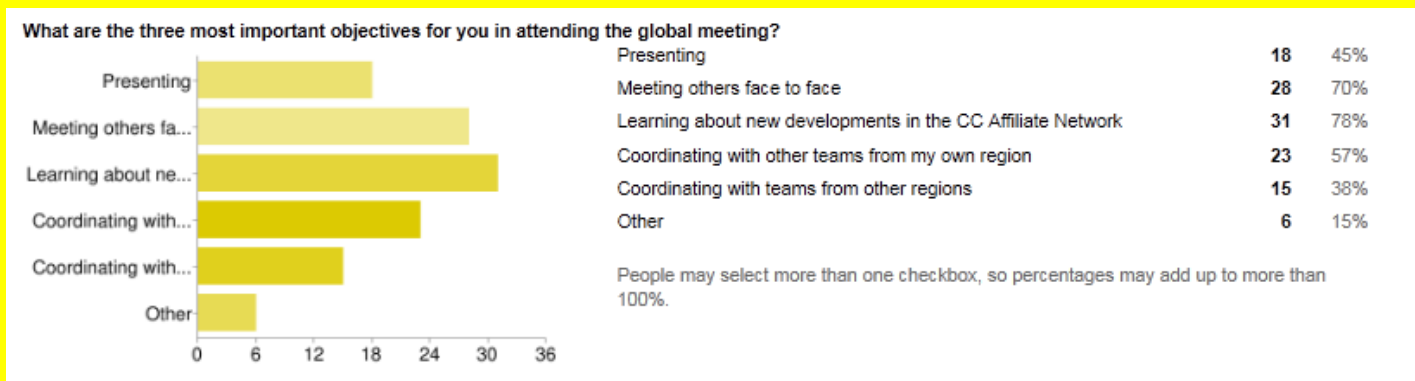

Goals and Objectives

Top Objectives

The potential attendees were asked to identify the three objectives most important to them. Learning about the Affiliate Network and Meeting Face to Face were the highest ranked objectives, with Coordinating with other Teams from My Region a bit behind those.



Desired Outcomes

Documents

There were a few document-type outcomes desired:

- Documentation of Creative Commons' current place in the world; Brochure of "CC Now" similar to *The Power of Open*
- Milestones and Project Plans
- Guidelines and recommendations of work for the next years

Clarity

By far, the biggest desired outcome is clarity, both in terms of CC's vision and goals and in terms of Affiliates position within CC.

Outcomes desired to increase clarity:

- Uniform communications policy
- Set of globally accepted principles and guidelines by which to present CC's position on international treaties
- Increased participation of the Affiliate Network in CC HQ decisions
- Better connections and improved communications between staff, affiliates and CEO
- Understanding of what happens in CC worldwide
- Better structure
- Clarification on the overall idea of CC; Clear goals and deeper understanding of CC vision
- Focused tasks to tackle
- Inspiration on what the current role is and direction needed

Collaboration

Most affiliates are looking forward to meeting face to face and learning from each other:

- New alliances with communities beyond CC
- Global contacts
- Increased regional coordination
- Learn from the network
- Share experiences and best practices

Specific Projects
